

Chefs Jacket SA/WA
Promotion Terms and Conditions

Information on how to enter and prize terms and conditions form part of these terms and conditions of entry.

1. This promotion begins on 4th June 2018 and ends on 26th August 2018 (“**Promotion Period**”).
2. The promoter is Fonterra Brands (Australia) Pty Ltd of Level 2, 40 River Boulevard, Richmond 3121 Victoria Australia (ABN 80 095 181 669) (“**Promoter**”).
3. Entry is only open to pre-qualified, non-existing Fonterra mozzarella customers, located in South Australia and Western Australia who order the Promoter’s products via a food service distributor (“**Eligible Entrant**”). Persons under the age of 18 are not eligible to enter on behalf of their employer.
4. Management and employees of the Promoter, its related bodies corporate, and agencies associated with this Promotion are not Eligible Entrants.
5. To enter, an Eligible Entrant must:
 - (a) Purchase the Minimum Amount (10 cartons) of the Eligible Products in a consecutive 4 week period during the 12 week Promotion Period through Fonterra representative via Turn-In-Order;
 - (b) Retain proof of purchase for verification. Invoice (proof of purchase) must clearly state the price paid per item, the number of individual items purchased in one transaction, the distributor from which the products were purchased, the date that the products were ordered, and business name and address details of the purchaser.
6. Only entries that comply with these terms and conditions are Eligible Entries.
7. Entries will be deemed to be accepted at the time of receipt into the Promoter’s database, and not at the time of transmission. Incomplete or incomprehensible entries will be deemed invalid.
8. At the end of the Promotion Period, if the Eligible Entrant achieves the Minimum Amount of Eligible Products they will be rewarded with a branded chefs jacket by the Promoter before October 9th 2018. This is not a game of skill.
9. There are a total of [40] prizes, 20 for South Australia and 20 for Western Australia with a total value of [\$2000] to be won:
 - (a) Branded Chefs Jacket [\$50].
10. Prizes are subject to terms and conditions and are not transferrable or exchangeable.
11. If a prize is unavailable for any reason, the Promoter, in its discretion, reserves the right to substitute the prize with a prize to the equal value and/or specification, subject to any written directions from the relevant regulatory authorities.
12. The Promoter accepts no responsibility for any tax liabilities that may arise from claiming or receiving the benefit of a prize.
13. Contacts of provisional winners will be notified with three business days of the conclusion of the promotion by telephone call from a Promoter’s representative. The provisional prize winners may be asked to provide the relevant proof of purchase, connected with the winning Eligible Entry, within three business days of the date of the notification. Failure to provide the proof of purchase in the time requested by the Promoter will result in the provisional winner forfeiting the prize. Provisional prize winners will only be deemed winners once verified by the Promoter in its absolute discretion.
14. The Promoter reserves the right, at any time, to verify and request proof of the validity of entries and entrants (including a Contact’s s identity, age and place of residence and/or employment) and to disqualify any entrant or Contact who, in the reasonable opinion of the Promoter, submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process.
15. If there is a dispute as to the identity of an entrant or Contact, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant who is to be awarded a prize. If more than one person attempts to claim a

prize, the Promoter has sole and absolute discretion to determine which of those persons has the rightful claim to the prize.

16. Prizes will be distributed to winners with verified proof of purchase within 6 weeks of the conclusion date by a nominated Promoter representative. In the alternative, prizes may be despatched via registered mail, addressed to the winner.
17. The Promoter accepts no responsibility for any prize that is lost, stolen or tampered with in any way. Prizes sent via registered mail to the winner discharges the Promoter's liability to award the prize to the winner.
18. Eligible Entrants and Contacts consent to the Promoter using their name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.

If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law to:
 - (a) disqualify any entrant; or
 - (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
