

## PERFECT YOUR PIZZA SKILLS IN LAS VEGAS

### TERMS AND CONDITIONS

1. The promoter is Fonterra Brands (Australia) Pty Ltd (ABN 80 095 181 669), 327 Ferntree Gully Road, Mt Waverley, Victoria, 3149 (“the Promoter”).
2. The “Entrant” is any eligible entity that has entered this promotion in accordance with these terms and conditions.
3. Information on how to enter, prizes, and other details contained within promotional advertisements form part of these terms and conditions. By entering this promotion, or using or taking a prize, the Entrant acknowledges that they have read and understand and agree to be bound by these terms and conditions. Entries not completed in accordance with these terms and conditions are void. Entries will be deemed void if stolen, forged, mutilated or tampered with in any way.
4. Entry is open to all Australian food service businesses who have purchased, in one transaction, at least \$200 (based on distributor invoiced price) of Eligible Products (as defined below) from their foodservice distributor, with at least two (2) different types of Eligible Products in the transaction, and have provided photographic evidence of proof of purchase as part of their entry. Refer to section 5 for the list of Eligible Products. Persons under the age of 18 are not eligible to enter on behalf of their employer.

All management and employees of the Promoter and its associated companies/ subsidiaries, and their immediate families, and all agents of the Promoter, are not eligible to enter.

The Promoter reserves the right to authorise product substitutions should any product be out of stock during the Promotional Period.

6. To be eligible to enter, the eligible business must purchase a minimum of \$200 (including GST) of Eligible Products, with at least two (2) different types of Eligible Products, in one transaction, during the Promotional Period, from one of the Promoter's distributors. To enter the promotion, an authorised representative on behalf of the business, must before 11.59pm AEST on 31 July 2017, enter all requested details to the entry website, [www.perfectpizzavegas.com.au](http://www.perfectpizzavegas.com.au), and upload photographic evidence of their distributor invoice containing the purchase of at least \$200 worth of Eligible Products (based on distributor invoiced price) in one transaction made during the Promotional Period. The invoice (proof of purchase) must clearly state the price paid per item, the number of individual items purchased in one transaction, the distributor from which the products were purchased, the date that the products were ordered, and business name and address details of the purchaser. The Promoter reserves the right to request that Entrants provide proof of purchase for all entries received. Failure by the Entrant to provide proof of purchase for each entry, may, in the absolute discretion of the Promoter, result in all of an Entrant's entries to be deemed invalid.

7. The promotion opens at 12:01am (AEST) on Monday 5<sup>th</sup> June, 2017 and closes at 11:59pm (AEST) on Sunday 30<sup>th</sup> July, 2017 ("the Promotional Period"). All entries must be received by the Promoter by 11.59pm (AEST) on Monday 31<sup>st</sup> July, 2017.

8. Entries will be deemed to be accepted at the time of receipt into the Promoter's database, and not at the time of transmission. Incomplete or incomprehensible entries will be deemed invalid. Only one (1) entry is permitted per qualifying purchase. Each business may enter a maximum of four (4) times throughout the Promotional Period with a maximum entry of one (1) entry per week. Entrants can only enter in their own name. The use of automatic entry software or similar devices is prohibited.

9. Entries will be divided into the following "State Groups": NSW/ACT, Vic/Tas, SA/NT, WA & Qld. The first valid entry drawn, from all entries received in each State Group, will each win the major prize as specified below.
